


<p><b>Reviewing a AT-AT Form 1 Record</b></p>	<p>This guide provides an overview of how AT-AT – DCAA FAO Reviewers <b>Review a DCAA Form 1 Record</b> sent to them by the DCAA Supervisor in the <b>Audit Tracking and Action Tool (AT-AT)</b> application that was sent to them by the DCMA Reviewer.</p> <p>Log in to PIEE and access the AT-AT application. In the AT-AT application go to the AT-AT Dashboard and locate the <b>‘My Work’</b> section. Only records assigned to the user may be reviewed by that user. To review a Record, locate the <b>‘Review Record’</b> icon directly next to the Record ID number. Click the icon to enter the record on the Form 1 Notice tab.</p>  <p><b>AT-AT – FAO Reviewer</b> have access to the “My Work” table on the dashboard; sort the column by Form 1 Notice Number to help filter the assigned records.</p>  <p>For <b>AT-AT - FAO Reviewer</b> looking for a Form 1 Record, use the <a href="#">Search Functionality</a>. To review as an <b>FAO Reviewer</b>, search for a record within your DoDAAC. Click the Record ID Hyperlink to open the record in view only from Search Results.</p>
<p><b>Record Header</b></p>	<p>The AT-AT Form 1 Record Header information is available at the top of the Review screen. Records open on the Form 1 Notice tab. All tabs are accessible during the review process. Continue with the training or select a tab link below to skip ahead.</p>

To begin adding attachments, select the Attachments tab and click the **Choose** button. Select all necessary attachments.

All selected attachments display below where they may be removed before upload.

After confirming all attachments are correct click the **Upload** button. After a successful upload, attachments display below on the document.

Uploaded attachments may be deleted.

The **Cancel** button next to the Upload button cancels the uploading of chosen attachments.

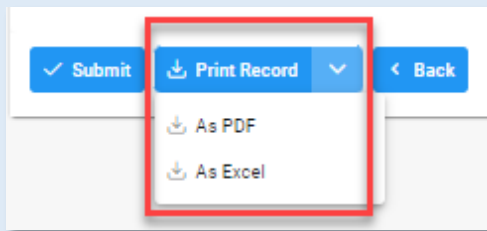
